## I. YEAR IN REVIEW

Rule 1.10, Minnesota Rules of the Client Security Board (MRCSB), provides:

At least once a year and at such other times as the Supreme Court may order, the Board shall file with the Court a written report reviewing in detail the administration of the fund, its operation, its assets and liabilities.

This sixteenth annual report of the Minnesota Client Security Board covers the Board's fiscal year, FY2003, which began July 1, 2002, and ended on June 30, 2003. Highlights from the past year include:

**Overview.** The Client Security Board met six times this past year under the leadership of this year's Chair Richard Diamond. The Board faced a comparatively quiet year in terms of claims, both in number and amount, with many of the claims being unearned retainer claims of relatively smaller amounts. Twenty-four of the 27 approved claims were either repayment of an unearned retainer or unused cost advance. These claims ranged in amount from as little as \$264 to a high of \$5,100. Fourteen of the claims were paid against one suspended attorney, Steven Soronow, whose practice was primarily in the area of immigration law.

Larger claims were paid arising out of fraud or theft situations against disbarred attorneys Murray Klane and Steve Samborski. Each of these attorneys was criminally prosecuted by the United States Attorney. The Client Security Board has paid 23 victims of Mr. Samborski a total of \$231,829.50 in the past two years. Although it was not particularly publicized, by the time of Mr. Samborski's conviction and sentencing, all of the victims identified in the federal indictment had been repaid in full by the Board. Thus the Board will become the recipient of any repayments by Samborski under his criminal restitution order.

Due to the slightly smaller claims load, the Board also took the opportunity to review certain Board policies and procedures, a regular periodic necessity to

ensure that the rules and decisions of the Board remain consistent and fair. This process will continue in the coming year to the extent possible.

New Director, New Home. In August 2002, Client Security Board and Lawyers Board Director Edward Cleary was appointed by the governor to the district court bench. The Supreme Court appointed a search committee to help seek a new director for the Client Security Board and the Office of Lawyers Professional Responsibility (OLPR). Martin Cole was named Acting Director. In December 2002, the Court appointed Kenneth Jorgensen as Director. Mr. Jorgensen previously was First Assistant Director for the Office of Lawyers Professional Responsibility. Although not previously associated directly with the Client Security Board, nevertheless based upon his prior position he is very familiar with the workings of this Board.

Also in August 2002, the Office of Lawyer Professional Responsibility moved to new offices in the Landmark Towers in downtown St. Paul.<sup>1</sup> Since the OLPR provides staff for the Client Security Board, its offices moved as well. Staff reports that the new offices are excellent. Board meetings will most likely continue to be held at the Minnesota Judicial Center.

**Statistics.** The Client Security Board paid 27 claims this year, in the total amount of \$140,271.88 (*see* Appendix 1, A. 1-2).<sup>2</sup> Thirty-six (36) new claims were

filed this past year. Twenty-four (24) claims were carried-over from the previous year. As noted, 27 claims were approved for payment, 20 claims were denied and one claim was withdrawn after being paid by the attorney. Thus, at the end of June 2003, only 12 claims against 11 lawyers remain pending before the Board, and seven of those remaining claims have related disciplinary or civil proceedings pending, completion of which the Board is awaiting prior to being able to resolve the claim.

Overall, after sixteen years of paying claims, the Board has now paid \$4.37-million on 382 claims against 106 lawyers (*see* Appendix 4, A. 5-7).

## II. THE CLIENT SECURITY BOARD AND ITS PROCEDURES

**Board Members.** As of June 30, 2003, the following individuals served on the Board (*see* Appendix 3; A. 4):

Richard Diamond was elected and served as the Board's Chair for the past year, and has now completed his second and final term on the Board. Mr. Diamond has always been a strong advocate for the claimant's point of view in resolving claims, a position he effectively combined with his leadership role this year. Pursuant to the Board's present policy of selecting the most senior lawyer member as its Chair, the Board chose Margaret Westin as it new Chair for the upcoming year at its most recent meeting. Ms. Westin has served on the Board for four years.

Two new Board members were appointed this past year: Gary Fuchs, an attorney from Eagan, and Sally DeLaittre Sawyer, a public member from

Minneapolis. Both have fit well with the collegial approach that the Board attempts to foster in its meetings.

Mr. Diamond was an appointee of the Supreme Court. A new Board member should be appointed by the Court shortly. The Minnesota State Bar Association (MSBA) nominates three of the attorney members; currently Ms. Westin, John Watson and Michael Rengel. Mr. Watson is eligible and expected to be appointed for a second three-year term on the Board. Sally DeLaittre Sawyer and Judith Pinke are the Board's two non-lawyer members.

Justice James Gilbert is the Board's liaison justice on the Supreme Court. He attended the Board's most recent meeting and made a presentation to departing Board Chair Richard Diamond.

Funding and Budget Procedures. All active lawyers in Minnesota paid \$17 per year to support the Fund through the end of this current fiscal year. In 1998, the Supreme Court recommended parameters for the fund of \$1.5-million and \$2.5-million, with the Board to report to the Court if the fund drops below or exceeds these figures. The Board presently projects a year-end balance in excess of the \$2.5-million amount, and projects a balance of near \$2.9-million after FY2004. Because of the Fund's health, last year the Board recommended to the Supreme Court that the assessment in favor of the Board could be lowered to \$12 per year per attorney starting with fiscal year 2004. This lower amount will slow the growth of the Fund and, absent a major defalcation crisis, the Fund balance should remain stable for the next few years, as income and expenditures will be roughly equal.

The Board does not handle any funds directly nor the investment of the Fund. The assessment is collected through the Office of Attorney Registration and placed into a segregated fund within the State Treasury. This past year the assessment generated approximately \$341,000. The Board also received approximately \$59,000 in

interest income and approximately \$25,000 in restitution payments from lawyers on whose behalf claims have been paid.

With the reduced assessment, the Board anticipates total income from all sources this coming year of approximately \$343,000. The Board has budgeted \$204,600 in total expenditures for next year. Based upon the information presently available to the Board concerning pending claims or known potential claims, \$150,000 has been budgeted for claims payment next year, slightly more than the current year's total. Just less than \$50,000 has been budgeted for staff services, travel for up to two Board members to attend a national conference on client protection,<sup>3</sup> supplies and any additional enhancements to the Board's computer database.

Administration. The Office of Lawyers Professional Responsibility provides staff services to the Client Security Board. As noted above, in December 2002 Ken Jorgensen became the Director of the Office of Lawyers Professional Responsibility and the Client Security Board. Assistant Director Martin Cole will continue to handle most daily operations for the Board. Mr. Cole also serves as a director-atlarge of the National Client Protection Organization (NCPO), and this year completed two terms as a member of the ABA's Advisory Commission on Client Protection Funds.

Following each meeting, the Board issues a press release pursuant to the Board's policy. The Board posts its press releases on the Board's Internet website<sup>4</sup> as well, in the hopes that the public better will be able to obtain information about the Board's activities. The site also contains answers to frequently asked questions (FAQ), the Board's rules, claim form, staff directory, a copy of the latest annual

report and an updated list of attorneys against whom claims have been paid, similar to that at Appendix 4 (A. 5-7). The site also has links to articles written about the Client Security Board.

The Minnesota Attorney General provides legal services to the Client Security Board in enforcing its subrogation rights against attorneys on whose behalf the Board has paid claims, or against any third persons from whom payments may be legally obtained. Attorney David Flowers is the Board's current attorney. He and Legal Assistant Laura Kelly provide outstanding representation for the Board. The Board pays no attorney's fees for this representation, but is responsible for direct costs of collection efforts and litigation. The final amount expected to be recovered this year is \$24,500. The Board has budgeted this coming year to recover approximately \$37,800.

Also as a part of the collection process, the Board may forward matters to the Minnesota Collection Enterprise (MCE), an agency created to assist government agencies in their collection work. Although the Attorney General continues to handle most matters for the Board that are to be contested, or that appear capable of prompt resolution, other matters are now referred to MCE to pursue.

Claims Procedure. Claims are initiated by submitting the claim to the Director's Office on forms approved by the Board. Claimants are provided the forms and a brochure to help explain the process. The claim form, and copies of the Board's rules are also available via the Internet at the Board's website. The respondent attorney is provided an opportunity to respond in writing, although frequently no response is received. The Board also has access to all lawyer disciplinary files, from which considerable information is often obtained.

The rules provide that claimants are expected to pursue reasonably available civil remedies. In order to avoid hardship and provide prompt claim resolution and payment, the Board occasionally exercises its discretion by waiving this

requirement when it is already known that the Attorney General will be pursuing litigation against the attorney under the Board's subrogation rights. One recurring situation where direct claimant efforts are appropriate is when the dishonesty involves forged instruments that were honored by a financial institution.

In most cases, attorney disciplinary proceedings will have been completed before any Client Security payment is made. The Board generally relies upon findings made in related lawyer disciplinary action concerning misappropriation, or in related civil or criminal cases whenever possible.

If a claim is denied, the claimant is notified in writing of the Board's determination and reasoning. The claimant has the right to request reconsideration and a discretionary meeting with the Board, so that all claimants have a full opportunity to present the merits of their claim.

## III. GOALS AND OBJECTIVES

As it does in most years, the Board will have a new Chair this year. Less frequently, the Board also has a new Director. Such changes in leadership have not signaled wholesale changes in the past, and are not expected to do so this coming year. The Fund's principal goal, as always, is to provide as close to 100% payment to 100% of the valid claims, subject to the Board's maximum payment of \$150,000. Prompt resolution of claims following disciplinary or criminal proceedings is the other major goal for the Board every year.




